Kennesaw State University limits academic residency for active-duty servicemembers (including Reservists and National Guardsmen) to no more than twenty-five percent of the degree requirements for all undergraduate degrees. Active-duty servicemembers can satisfy academic residency requirements at any time during their program of study, specifically avoiding any final year or final semester residency requirement, subject to stated requirements in specific course areas such as majors.

Kennesaw State University has been approved as a designated member of the Servicemembers Opportunity Colleges Consortium (SOC). As a member of the SOC Consortium, Kennesaw State University affirms its commitment to fair, equitable, and effective policies and practices that recognize and deal with the special conditions faced by military students who want to obtain a college education.
