1. Adult Learning Committee Policy Changes – Michelle Head (15 minutes)

Michelle Lee: Coursera, industry training and other industry facilities. Relaunch credit for prior learning, and look into current policies. Currently exists in undergraduate catalog. A graduate policy is crafted. Includes at undergraduate prior learning assessment.

Greg Wiles: Chair of ALC. Three policies:

UNGR 6.7 Credit for Prior Learning

Credit for prior learning is offered for select undergraduate courses when a student demonstrates satisfactory competency for course learning outcomes. A complete listing of eligible courses for credit for prior learning can be found on the KSU Credit for Prior Learning website. The graduation residency requirement serves as the limit for the amount of Credit for Prior Learning a student may receive. This is because Credit for Prior Learning hours are not applied toward the institutional graduation Residency Requirement. Credit for Prior Learning hours are not calculated in the Institutional GPA.

6.7.1 Credit for Prior Learning – Completed Prior to Acceptance to KSU

The following are opportunities that are completed prior to acceptance to KSU:

Advance Placement (AP)

International Baccalaureate (IB)

Cambridge International (A and AS Levels)

Caribbean Advanced Proficiency Examination (CAPE)

Credit for prior learning after being enrolled.

PROPOSED GRAD CREDIT FOR PRIOR LEARNING POLICY

Credit for prior learning is offered for select graduate courses when a student demonstrates satisfactory competency for course learning outcomes as demonstrated by an industry certification, performance on a department exam, or portfolio. A complete listing of eligible courses for credit for prior learning can be found on the KSU Credit for Prior Learning website.

A graduate student is eligible to earn credit for prior learning before or within their first semester of enrollment, prior to earning any credit, ~~into~~ one of the University's graduate programs. A graduate student may earn a maximum of 30% of the total credit hours of their graduate degree through credit for prior learning. A fee will be assessed for each certification evaluation, institutional examination, or portfolio review attempted; no course may be attempted more than once. A passing grade of 80 percent or higher on the department exam or portfolio is required to receive course credit. If the required score for the examination is met, students will receive the credit equaled with the course. Credit for prior learning credit is considered residential credit, ~~and will be noted as a "K" grade on the transcript~~. As a result, this type of credit is not calculated in the Institutional GPA. A student may submit an appeal, using the appeal process described here {Academic Policy 3.6}, ~~if a student feels an incorrect grade has been awarded, they may submit an appeal using the appeal process described on the XXX website (link)~~

2. Search Guidelines Changes – Bill Griffiths (15 minutes)

Senate passes resolution to provide rankings for candidates: compromise:

Two types of searches (Faculty searches: Committee would decide details including feedback and rankings) And administrative search will include strengths and weaknesses and areas of concern.

David Bray: Is department chair the hiring manager? Yes

Scott Ritchie: Can a dean instruct a search committee for instructional faculty not to rank order finalists? No

Heather Pincock: Did you add the concern about the candidate suggested by the faculty?Yes

A footnote on the page: Search firm may be used. The committee should be involved in the reference checks.

Bill: I do not know when it will be approved and when we will formally be operating under these guidelines. Vote: New search guideline compromise: Can you live with it? passed 100%

3. P&T process review committee recommendations – Carmen Skaggs (15 minutes)

Promotion and PTR Workflow

- Build two separate workflows in Watermark, and candidates choosing elective promotion in a required PTR year would be required to submit to both workflows—the promotion workflow and the PTR workflow—on their regular schedules.

Elective Withdrawal Process

- Eliminate the paper withdrawal form; replace with dropdown box in Watermark in the Faculty Response steps, asking faculty to declare their intent to withdraw the portfolio. The faculty member would then select “withdraw portfolio” from their Action steps (See sample screenshot from a faculty response step in workflow.)

Elective Withdrawal Process (continued)

- Adjust the review timeline for Pre-tenure review so that it doesn't begin until after the college dean's review (step prior to Provost's level review); then, a candidate who withdraws from P & T review could be placed on the Pre-tenure review workflow before it begins. (See revised schedule below.)
- Launch both P & T workflow and required Pre-tenure workflow for candidates undergoing elective tenure review with 3 years probationary credit; if they withdraw from the promotion review, the pre-tenure review would continue on the regular pre-tenure schedule.
